

Open Platform Registration Agreement

This Service Agreement is an effective contract jointly concluded between the OP Retail Open Platform website (hereinafter referred to as "OP Retail") and the user (hereinafter referred to as "You"), which is binding on both parties.

OP Retail provides users with the products and services displayed on this website (hereinafter referred to as "OP Retail Services" or "the Services"), and will continuously update the service content. The latest OP Retail Services shall be subject to the relevant product and service introduction pages on this website and the services actually provided to users.

1. General Provisions

- a) You confirm: Before using the Services, you have fully read, understood, and accepted all the contents of this Service Agreement (especially the content marked in **bold** and/or underlined). Once you select "Agree" and complete the registration process or use the Services, it signifies your agreement to abide by all the provisions of this Service Agreement.
- b) You agree: OP Retail has the right to unilaterally modify this Service Agreement and the corresponding service rules at any time, and has the right to announce such changes via message push, webpage announcement, or other means, without the need to notify you separately. If you continue to use the Services after the announcement of changes to the content of this Service Agreement, it indicates that you have fully read, understood, and accepted the modified agreement content, and will use the Services in accordance with the modified terms. If you do not agree to the modified service terms, you shall immediately cease using the Services.

2. Account

- a) Eligibility Confirmation: When you complete the registration process or actually use the Services through other means permitted by OP Retail, you shall be a natural person, legal person, or other organization (hereinafter collectively referred to as a "Legal Entity") with full civil rights capacity and full civil capacity for conduct.
- b) If you are a minor or a person with limited civil capacity, you do not possess the aforementioned eligibility. You and your guardian shall bear all consequences arising from your improper registration. OP Retail has the right to cancel (permanently freeze) your account and claim compensation from you and your guardian.
- c) After you fill in the information as prompted on the registration page, read and agree to this Service Agreement, and complete the entire registration process, or when you actually use the services of this website through other means permitted by OP Retail, you are bound by this Service Agreement. You can use relevant login credentials to access this website.
- d) You understand and agree that upon successful completion of the registration process on this website, you have obtained an OP Retail Open Platform account.
- e) You understand and agree that to ensure account and transaction security, OP Retail has the right to require you to complete real-name authentication for your OP Retail Open Platform account at any time. Simultaneously, OP Retail may require you to provide more identity documents and information for the activation of certain products or services, to conduct further identity authentication or qualification verification. Your Open Platform account will only be eligible to use the relevant products or services after passing these authentications and verifications.

3. Information

a) When completing the registration or activation process, you shall accurately provide and promptly update your information in accordance with legal requirements and the prompts on the corresponding pages, ensuring it is true, timely, complete, and accurate. If there are reasonable grounds to suspect that the information you provided is erroneous, untrue, outdated, or incomplete, OP Retail has the right to issue a notice to inquire and/or request correction, and has the right to directly delete the relevant information, or even suspend or terminate providing part or all of the services to you. OP Retail shall bear no responsibility for this, and you shall bear any direct or indirect losses and adverse consequences arising therefrom.

b) You shall accurately fill in and promptly update your provided contact information such as email address, telephone number, contact address, postal code, etc., so that OP Retail or other members can effectively contact you. If you cannot be contacted through these means, resulting in any losses or increased costs incurred during your use of OP Retail Services, you shall bear the responsibility entirely and solely. You understand and agree that you have the obligation to maintain the validity of the contact information you provide. If changes need to be updated, you shall operate according to OP Retail's requirements.
